Visitors to the garden will determine the People's Choice Award winner. Our Executive Director will also select a winner for "Executive Director's Choice". The winners will be announced on our social media and in our e-newsletter.

## Guidelines for your Scarecrow

### Size/Location:

- Each Scarecrow will have a 6'x6' space to occupy. Please try to limit your scarecrow to 50 lbs.
- If you should need a traditional T-Post for your scarecrow, it can be requested ahead of time. The T-Post will be placed in the Garden and then you will be able to attach your scarecrow to the post.
- Each Participant will be assigned a spot in the Gardens.
- Set-up is Monday, September 15th through Friday, September 19th. You must have an appointment to setup your scarecrow. Another time/date may be available if needed, please reach out to Haley (hligon@bellingrath.org).
- Adjustments can not be made after it has been installed by Garden staff or after agreed set up time.
- Removal takes place beginning Friday, November 1 through November 8, 8 am - 4 pm. No appointments needed. Note: All scarecrows left in the Garden after November 8, will be disposed.

### Materials:

- Scarecrows can not have any of the following:
  - Live Plant materials
  - Real Pumpkins
  - Real Food/Candy
- Stuffing can be anything but newspaper or water soluble peanuts. (These items could be placed in plastic bags.)
- Entry should be durable and weatherproof.
- Clothing that does not fade easily like nylon or polyester. (Spray Scotchgard on the inside/outside to prevent mildew.)
- Any scarecrow that deteriorates to an unacceptable level during the month will be removed.
- Bellingrath Gardens & Home is not responsible for loss/damage.

### Themes:

- Scarecrows must be suitable for viewing by children.
- Any entries in poor taste for family viewing, depicting controversial subjects or overly commercial, political, or religious in nature will not be accepted.
